Eligibility Criteria & Mandatory Conditions

NOTE: The bid documents are not transferable and the firm's seal and signature of the authorized official must appear on all papers and envelopes submitted.

- 1. Bid shall be submitted in TWO PARTS, viz. **Technical Bid** comprising (i) EMD should be in form of Bank Guarantee / Demand draft drawn in favor of The Secretary, Bihar Rajya Madhyahan Bhojan Yojana Samiti , Patna; (ii) technical details, compliances etc. as enumerated in the tender document & and **Financial Bid**. The bid should be submitted in properly wax sealed covers indicating the Bid detail. Address of the firm submitting the tender and the officer to whom the tender is addressed, must appear distinctly on both the inner and outer sealed covers, indicating also on each envelop TECHNICAL BID/FINANCIAL BID as may be applicable. The technical proposal must not include any document / information related to financial proposal.
- 2. Tenders will not be accepted without the specified earnest money Tenders received after the prescribed time and date will not be accepted & considered
- 3. Bidder, either manufacturer or its authorized dealer, should be an ISO 9001 & 27001 certified company.
- 4. Authorization certificate of the OEM of quoted Tablet PC brand, in case bidder is not manufacturer itself, specific to this tender.
- 5. The Bidder will have to submit invariably VAT/sales tax registration number from the Commercial Taxes Officer concerned without which the tenders will not be considered. The Bidder will also submit the latest VAT/Sales Tax clearance certificate.
- 6. The Bidder should have experience in terms of sales of Laptop/Tablet PC/GPS & GPRS device/Touch Pad/ in any Government / PSU department in India, valued minimum Rupees seventy five lacs in single order in last three per years (10-11, 11-12, 12-13), having installation / supplies upto district level of Bihar.
- 7. Bidder to enclose Copy of PAN/TIN number.
- 8. Bidder should have a service office in Bihar with complete contact details.
- 9. The quoted brand / OEM should have been into business of tablet PC manufacturing for at least three years as on date of bidding.
- 10. The quoted brand / OEM should have Service Network in Bihar, minimum fifty locations. Bidder to enclose list under seal of OEM with **bidders list of district level engineers**.
- 11. The quoted brand / OEM should have been into business operation in India, through their direct sales and service offices in India, for minimum five years as on date of bidding. Proof to be enclosed.
- 12. The bidder is required to submit a sample unit, strictly as per tendered specks, for technical evaluation, testing the performance of application developed and or being used by the department. This will be part of technical evaluation and Tablet PCs found to be best suited for the application will only be approved and remaining will not be considered as technically qualified.
- 13. The quoted brand / OEM should be ISO 9001:2008 certified.
- 14. Bidder to enclose Technical Literature along with a printout, of the quoted Tablet PC directly taken from the OEM official website, having details exactly as per tendered specification. The printout should clearly show the URL of the website and date of download, duly verifiable during evaluation from the same website.
- 15. Bidder if not OEM then compliance of specifications should be under signature of OEM
- 16. Bidding company should have been into existence for atleast five years as on date of bidding.

- 17. Bidder should enclose Proof of annual turnover (Audited Balance Sheet) of having average yearly turnover of Rupees five crores in three financial years (10-11, 11-12, 12-13).
- 18. Bidder should have a valid PAN/TAN number from Income Tax department as on tender publishing date along with the Technical Bid;
- 19. Banker's details of tendering FIRM / Bidder should be clearly mentioned;
- 20. Warranty of the quoted Tablet PC (including battery) shall be minimum three years onsite and one year onsite on accessories. The Supplier of Tablet PCs shall keep at least 2% equipment as spare, to provide immediate replacement, with the service centre during the warranty period.
- 21. Earnest Money (EMD) of Rs 2,00,000.00 (Two lacs), in the form of Bank Guarantee / demand draft only, drawn in favor of The Secretary, Bihar Rajya Madhayahan Bhojan Yojana samiti, Patna
- 22. In the case of bidders whose bids are accepted for undertaking the work assigned for this tender, this successful bidder will submit a Performance Security deposit, which will be equal to 5% (Five percent) of the contract price that the bidder has quoted in Financial Bid. The same would have to be in form of irrevocable valid Bank Guarantee for the entire warranty period and would have to be submitted within 15 days from the issuance of the work order.
- 23. Earnest Money Deposit of the successful bidder will be refunded on receipt of Performance Security Deposit from the bidder.
- 24. This is a turnkey based tender. Bidder must quote for all items.
- 25. This is a tender invitation for turnkey based requirement. Therefore bidder must quote and qualify for all required items.
- 26. No partial compliance of any terms, specification, etc. permitted partial compliance and deviation of any terms and or condition will automatically lead to rejection.

- 01. Rates: Rates quoted should be on F.O.R rate district level on Door Delivery basis.
- 02. Validity: Quoted rates must valid for 90 days.
- 03. Delivery: Unless otherwise stated delivery of goods will have to be within Four weeks from the date of issue of the Purchase Order. All aspects of safe delivery shall be the exclusive responsibility of the OEM/Bidder. Any unjustified and unacceptable delay in delivery beyond the delivery schedule as per purchase order will render the Bidder/Manufacturer liable for liquidated damage at the rate of 0.5% (half percent) per week, subject to maximum of 5% beyond which order will be cancelled, EMD forfeited besides recovery of LD.
- 04. Late and delayed Tenders: Late and delayed tender will not be considered. In case any unscheduled holiday occurs on prescribed closing/opening date the next working day shall be the prescribed date of closing/opening.
- 05. Ground for Rejection of Tender: The tenders are liable to be rejected if any of the fore going conditions are not complied with and must be strictly as per this tender document. The tender should be complete in all respects and duly signed wherever required. Incomplete and unsigned offer will not be accepted.
- 06. Entry Tax: Entry tax, if applicable will be borne by the bidder.
- 07. TDS as applicable shall be deducted at source from the Bill.
- 08. Any loss or damage caused to the article in transit is to be made good by the bidder free of cost within reasonable time.
- 09. Security Deposit / EM can be forfeited in case of non supply / part supply / delayed supply of material unless permitted by the customer.
- 10. No escalation in respect of materials, labor, freight etc. will be allowed in any shape.
- 11. A declaration should also be furnished by the agency that they will supply the original product of the manufacturing company. In case of supply of duplicate product suitable

- action will be taken against the agency including forfeiture of EMD and Security Deposit.
- 12. The rates should be quoted and legibly written both in words and Figures.the same must be attested by the bidder with full signature; however no overwriting is permissible.
- 13. In case of any discrepancy between words and figures, in financial bid, the rates in words shall be accepted as correct.

Undertaking by the Bidder

I have read all the terms, conditions, enclosures and the whole tender document and understood the contents. I am also authorized by my firm to fill in this tender and therefore I am submitting this in the form of undertaking. Apart from that agree to abide by the following:

- 1. Certificate of satisfactory past performance (last 3 years) has been enclosed.
- 2. We will ensure that a minimum of 98% uptime, calculated on an annual basis is achieved for the supplied items.
- 3. We shall give benefit of any price reduction found by the time of placing the supply order.
- 4. We agree to accept partial order if it is placed.
- 5. We have quoted rates of items for three years comprehensive warranty on tablet PC and one year on accessories, with spare and labour.
- 6 In case of test results showing that supplies are not up to the prescribed standard of specifications, the supplier shall change the whole lot but within the stipulated delivery period, and the cost of the test will be borne by the supplier.
- 7. Articles not approved during inspection or testing shall be rejected and will have to be replaced by the bidder at his own cost within the time.
- 8. The rejected articles shall be removed by the bidder within 3 days of intimation of rejection, after which Samiti shall not be responsible for any loss, shortage or damage and shall have the right to dispose of such articles as he thinks fit, at the bidder's risk and on his account.
- 9. The bidder shall be responsible for the proper packing so as to avoid damage under normal conditions of transport by sea, rail and road or air and delivery of the material in the good condition to the consignee at destination. In the event of any loss, damage, breakage or leakage or any shortage the bidder shall be liable to make good such loss and shortage found at the checking/ inspection of the material by the consignee. No extra cost on such account shall be admissible.
- 10. The Contract for the supply, can be repudiated at any time by the Purchase Officer, if the supplies are not made to his satisfaction after giving an opportunity to the bidder of being heard and recording the reasons for repudiation
- 11. It is undertaken that no item supplied is used/reprocessed or refurbished in any manner either in part or otherwise.
